

Income Eligibility Guidelines for Free and Reduced-price Meals or Free Milk

Effective from July 1, 2018 to June 30, 2019

Households with income at or below the following levels may be eligible for free and reduced-price meals or free milk. The household size and Income Eligibility Guidelines charts below have been prepared in a format that allows you to copy and paste them into the Media Release and Letter to Households.

National School Lunch and School Breakfast Programs

- Both free and reduced-price eligibility scales must appear in the Public Media Release
- Only the reduced-price eligibility scale must appear in the Letter to Households

Special Milk Program

- Only the free eligibility scale must appear in the Public Media Release and Letter to Households
